## Consultant Fee Schedule for 2014-15

### On-Site Consulting (individual days):

- Members:
  - \$650 per full day
  - \$450 per half day (available only to SWPRSC members)
  - Hourly Virtual Consulting Rate: \$125/hour (minimum 1 hour; Skype, GoTo, IDL)
- In-State Non-Members:
  - \$1200 per day plus travel expenses (no half day rates)
- Out-of-State Non-Members:
  - \$1700 per day plus travel expenses (no half day rates)

### On-Site Consulting (multi-day packages, requires advance, lump-sum payment):

- Members:

○ 5 days for \$3,125	(\$625/day)	25 days for \$14,625	(\$585/day)
○ 10 days for \$6,150	(\$615/day)	30 days for \$17,250	(\$575/day)
○ 15 days for \$9,075	(\$605/day)	35 days for \$19,775	(\$565/day)
○ 20 days for \$11,900	(\$595/day)	40 days for \$22,200	(\$555/day)
- In-State Non-Members\*:
  - 5 days for \$5,000 plus travel expenses of round-trip mileage, meals, & lodging (\$1000/day)
  - 10 days for \$9,500 plus travel expenses of round-trip mileage, meals & lodging (\$950/day)
  - 15 days for \$13,500 plus travel expenses of round-trip mileage, meals & lodging (\$900/day)
- Two Non-Members Combining:
  - Rate x 1½ plus travel expenses (ex: 5 days: \$5,000 + \$2,500 = \$7,500 plus travel expenses)
- Daily rates are plus travel expenses from consultant's home

### \*In-State Non-Member Trainings (i.e., Cooperative Learning, Thinking Maps, etc.):

- Full day for 0-50 participants - \$1200 plus travel expenses
- Full day for 50-100 participants - \$1500 plus travel expenses
- Full day for 100+ participants - \$1800 plus travel expenses
- Daily rates are plus travel expenses are from consultant's home

### Executive Team Services:

- Dr. Kelly Gillespie, Executive Director/CEO: \$850/day with no discount for multiple days
- Mike Ronen, Assistant Executive Director/CFO: \$750/day with no discount for multiple days
- Jim Lentz, Senior Leadership Consultant: \$750/day with no discount for multiple days
- In-state, non-member rate for Executive Director will be \$200 more per day than rate noted in above sections..
- In-state, non-member rate for Assistant Executive Director and Leadership Consultants will be \$100 more than rate noted in above sections.

### NKESC/SWPRSC Members (mileage rate as set by SWPRSC Board of Directors):

- All member rates apply with addition of roundtrip mileage from Scott City to host district.

### Gold Members (mileage rate as set by SWPRSC Board of Directors):

- All member rates apply with addition of travel expenses of round-trip mileage from consultant home district to host district, meals, & lodging.
